

Wings of Carolina Flying Club 14 C.F.R. Part 68 Compliance Certificate

Federal Aviation Administration (“FAA”) regulations require any person acting as pilot in command to hold a current “Medical Certificate” issued under 14 C.F.R. Part 67 or to comply with 14 C.F.R. §61.113(i), 14 C.F.R. §61.23(c)(3), 14 C.F.R. Part 68, and related sections (collectively referred to as “BasicMed”). The Wings of Carolina Flying Club requires all Members acting as pilot in command to file with the Club in accordance with SOP II.11 a copy of a current Medical Certificate or this Part 68 Compliance Certificate.

The undersigned, a Member of the Wings of Carolina Flying Club, certifies and acknowledges:

- (1) It is the responsibility of each Member to understand and comply with all FAA Regulations affecting his or her right to act as pilot in command and this form is not intended to summarize completely all of the requirements of BasicMed. The undersigned will not fly at any time not authorized under FAA regulations.
- (2) The undersigned intends to fly without a current Medical Certificate under BasicMed and therefore certifies as follows:
 - a. I will comply with all medical requirements or restrictions associated with my U.S. driver’s license, which is current and in effect (14 C.F.R. §61.23(c)(3)(i)(A)).
 - b. I have filed with the Club my most recent Medical Certificate, which was held after July 14, 2006, (14 C.F.R. §61.23(c)(3)(i)(B)) and which has not been suspended, revoked or if a Special Issuance certificate, withdrawn (14 C.F.R. §61.23(c)(3)(ii)) or have provided alternative documentation approved by the Chief Flight Instructor.
 - c. My most recent application for a Medical Certificate submitted to the FAA has not been completed and denied (14 C.F.R. §61.23(c)(3)(ii)).
 - d. If I have any mental health disorder, any neurological disorder, or any cardiovascular disorder denominated in 14 C.F.R. §68.9, I have obtained the Special Issuance of a Medical Certificate required by that section.
 - e. I have completed the medical education course set forth in 14 C.F.R. §68.3 during the 24 calendar months before acting as pilot in command in an operation conducted under 14 C.F.R. §61.113(i) and retain a certification of course completion in accordance with 14 C.F.R. §68.3(b)(1).
 - f. I have received a comprehensive medical examination from a State-licensed physician during the 48 months before acting as pilot in command of an operation conducted under 14 C.F.R. §61.113(i) and that medical examination was conducted in accordance with the requirements in 14 C.F.R. Part 68;
 - g. I am under the care and treatment of a State-licensed physician when acting as pilot in command of an operation conducted under 14 C.F.R. §61.113(i) with respect to any medical condition that may affect my ability to fly.
- (3) I acknowledge that whether or not I meet the requirements of BasicMed, it remains my responsibility to self-assess my medical condition to determine whether it is safe and legal for me to fly.

I certify and acknowledge that the foregoing is true and correct and will not act as pilot in command of a Wings of Carolina Flying Club aircraft at any time this is not the case.
