

Dear Prospective Wings of Carolina Flying Club Member:

Congratulations on your decision to join the Wings of Carolina Flying Club! We are excited to have you as a new member. Our goal is to make it as safe, fun, and affordable as possible for you to meet your aviation goals.

There is often a waiting list to get paired with an instructor. If you are a current pilot needing a check-out in club airplanes, that can usually be accommodated more quickly than if you need instruction toward a certificate or rating. Please email vp@wingsofcarolina.org to find out about the current waiting list.

Here is what you need to do to join:

- 1. Carefully read the next page entitled **IMPORTANT INFORMATION FOR PROSPECTIVE MEMBERS**.
- 2. Complete the Membership Application in full. Be sure to indicate your current status as a new, student, or licensed pilot. Please indicate which member type you are applying for at the top of the form.
- 3. Determine the payment amount to submit with your application and attach a check for the appropriate amount and made out to "Wings of Carolina Flying Club" to your application. The required payment amount varies by member type and the type of aircraft you intend to fly. You have three options:

Join Today: You can join the club right now at the non-flying "**Member**" level and enjoy all the other privileges of membership while waiting to be paired with an instructor. To do so, consult the table below to determine what your initial payment will be. Upon being paired with an instructor, your member level will be converted to "Full Member", and you'll start being charged Full Member dues of \$90/month.

Waiting List Only: If you would like to wait to join the club until your name comes up on the waiting list to be paired with an instructor, select this option. In that case, attach only the \$250 non-refundable application fee. Your application will be retained until your name comes up on the waiting list. At that time, an aircraft deposit and one month's dues will be payable, and then you will become a club member at the "Full Member" level.

Join as Associate Member: To join at this level, attach a check for \$50. That covers the \$25 non-refundable application fee and \$25 for one month's dues. This level is for members who do not intend to fly club aircraft.

- 4. Make 2 photocopies of your state driver's license. If you currently possess a FAA medical certificate and/or pilot certificate, please include them on the same copy with your driver's license.
- 5. In a sealed envelope, return the completed **Membership Application**, the two photocopies, and the check for **required payment amount** to:

- 6. Request a copy of your driving record for the past seven years be sent to the Club for review. The information is essential to our risk management process for insurance purposes. All information released to the Club will be kept confidential.
 - a. For NC, complete NC DMV form DL-DPPA-2 (page 4) which authorizes the DMV to release information about your driving record to the Club. Mail the completed NCDMV form and a check for \$10.75 payable to NCDMV to the address listed on the DMV form. DO NOT SEND THIS FORM TO THE WINGS OF CAROLINA WITH YOUR APPLICATION!
 - b. If you have had a NC driver's license for less than seven years, you must arrange for your driving record from the prior state(s) where licensed to be sent to the WCFC Vice President. Please refer to each respective state Division of Motor Vehicle's website(s) for the process for that state.

IMPORTANT INFORMATION FOR PROSPECTIVE MEMBERS

(PLEASE READ BEFORE SUBMITTING APPLICATION)

Responsibilities of Club Membership

The Wings of Carolina Flying Club is an organization created to provide aeronautical education and experience at the most reasonable cost. Membership is open to any interested individual who demonstrates an attitude of safety consciousness, courtesy and service to the Club and community and agrees to abide by the Club's Bylaws and Standard Operating Procedures (SOPs). Please note that Club SOPs are frequently more rigorous than FAR requirements (ex. Requirements for fuel minimums). Compliance with all Club SOPs is mandatory.

The Club is organized so that all members have an experience similar to owning an aircraft. With that experience comes significant responsibility. In order to maintain a rate structure compatible with an affordable aeronautical experience, the Club depends primarily on volunteer efforts for most routine activities. These activities include service projects such as participating in 50 hour maintenance on the aircraft, maintaining the Club Operations building and grounds, and regular cleaning (washing, waxing and vacuuming) of aircraft. Volunteer effort is expected from all members. The Club does not merely rent aircraft; we share the use of aircraft and jointly look after those aircraft as if they were our own.

Membership Levels

- Full Members can reserve and fly Club Aircraft and vote in Club elections.
- <u>Members</u> do **not** have flight privileges but can vote in Club elections. Member status may also be used by Full Members to reduce their dues during a time away from flying of 3 months or longer. Notify vp@wingsofcarolina.org via email to request a change of status.
- <u>Associate Members</u> typically have their own Aircraft and just wish to participate in club activities and have access to the Club facility. Associate members do not have flight privileges and cannot vote in Club elections.
- Note:
 - Both Members and Full Members must maintain an Aircraft Deposit with the Club.
 - o See the Member Handbook for full details on each membership level.

Membership Applicant Screening Procedure: Driver's License Record Check

It is the policy of the Wings of Carolina Flying Club to review an applicant's motor vehicle record for the **seven** year period prior to the application date. In general, it takes about two weeks for the NC DMV to provide the records for an applicant with a NC driver's license. For an applicant with a **current out-of-state license or a NC driver's license held for less than 7 years**, the other state must be contacted for the record – <u>this is your responsibility</u>. The process may then take 6 to 8 weeks. For an applicant with a **driver's license from another country**, it is <u>YOUR RESPONSIBILITY</u> to provide an English language copy of your driving record.

While the license review is pending, new student pilot members may begin dual flight training with an instructor. New licensed pilot members may begin their check-out in the type of Club aircraft that they plan to fly. However, a new member applicant may not solo in a club aircraft until their record check is complete and the application is approved.
